NEVADA SECTION SUMMER MEETING JUNE 6 & 7, 2008

President Elect Ken Conley invites all to the 2008 summer meeting to be held at the University of Nevada Gund Ranch in central Nevada. The topic of the event will be targeted grazing. Learn about fall grazing to control cheatgrass utilizing cattle. This is year two of a three year study and some interesting results are being observed. We will also discuss the grazing scheme at the ranch which involves matching cattle nutritional needs to seasonal forage availability. Time permitting we will also observe efforts to restore Great Basin wildrye in some degraded sites. Friday's tour will begin at 9 AM with an introduction at the ranch HQ followed by on the ground presentations and discussion. The business meeting on Saturday will begin at 8 AM.

Lunch and dinner Friday and Saturday breakfast is included in the registration cost. Every effort will be made to have enough food but meals cannot be guaranteed with late registration! See registration form following. We welcome members from the California and Idaho Section and encourage anyone interested to attend and find out about SRM.

Facilities:

A bunkhouse is available and could house 6-10 individuals if need be. Restroom facilities are available in the bunkhouse and port-a-toilets will be on site. Camping is available on the main lawn at the ranch or in one of the many canyons near the ranch. A



Directions:

The Gund Ranch is located in central Nevada at Walti Hot Springs 45 miles north of Austin. From Highway 50 take Grass Valley Road 6 miles East of Austin. 39 miles, follow the signs.

From Highway 278 take JD Ranch Road at the rest stop. Go west 21 miles to Grass Valley county road, turn south 9 miles to Walti.

From I 80 take Beowawe Exit, go south through Crescent Valley to Cortez Gold Mine, cross the haul road , 25 miles south to Walti Hot Springs.

BOB WILSON – REST IN PEACE

(From Bob's candidate bio and eulogy given by Maria Ryan in Ely.)

Bob Wilson was a native of northern Elko County in Nevada and Owyhee County in Idaho. He descended from families that settled in this border area in the mid 1800's.

Bob grew up working on various ranches in Owyhee and Elko Counties until he enlisted in the US Navy Seabees and served in Vietnam. After the war he completed a B. S. in Agriculture Resource Economics at UNR. It was there he met and married his wife, Ida. He then went to work for the Montana State University Cooperative Extension Service as their Lincoln County Cooperative Extension Agent in Libby, Montana. While there he took a sabbatical leave to complete his Masters in Plant Science, again at UNR. Bob and Ida's two sons, Brandon and Eric, were born while they lived in Montana.

Seeing an opportunity to return near home, in 1995 he took the position of Extension Educator with UNR Cooperative Extension in Ely, Nevada. Bob worked extensively with public collaborative processes, conflict over natural resources of all types, and the ecological consequence of noxious weed invasions into functioning ecosystems

Bob was committed to so much in this country. He was in the middle of everything. He knew everyone and everyone knew they were welcome to speak their minds and Bob would listen. He may not have agreed, Bob knew his own mind, but he enjoyed discussion – political, scientific, personal, it didn't matter the subject. He was always looking for a way to get things done, and a better way to get things done, for a better result, for a better community, better environment. Bob was an optimist if ever there was one. His optimism brought better health to Eric, better research and extension ideas to Montana and Nevada, better community relations on tough issues, and better ways to get important work done.

Bob was happy, curious, just a little bit rebellious, and a lot of heart. Most of all Bob was about service. He served this county and the state of Nevada with honor and dedication. One of the best things about Bob was his stories. Bob had great stories. Stories of things he'd done or what colorful friends had done, but there were always great stories.

We wish him Godspeed and will, in his honor remember the way he lived – full out and up, committed, optimistic, and kind hearted.


THE PROGRESSIVE RANCHER VENTURE
