Nevada Section SRM is committed to the development, synthesis, dissemination, and application of sound scientific information that is relevant to the present and future needs of rangeland management in Nevada.

Key actions for this goal are research, trials, synthesis papers, demonstration projects, and final extension of knowledge and experience to on-the-ground application of full-scale projects. Applicable metrics are the number and variety of such actions.

3.5 Youth and Student Development

Nevada Section SRM is committed to increasing young people's knowledge and understanding of the importance of rangelands as key components of environmental quality and quality of life. Education and development of Nevada's youth and college students concerning the importance of rangelands as environmental and economic assets is key to meeting this commitment.

3.5.1 Actions

Actions for this goal include continued development of the Nevada Youth Range Camp, mentoring for High School Youth Forum participants, mentoring college students, support of rangeland programs at Great Basin College and the University of Nevada-Reno, and college scholarship(s). Number of participants and amount of sponsorships are key metrics.

3.7 Financial Health

NVSRM is a member-based society, with elected and appointed council members, who manage the financial affairs of the section. Income sources include donations, revenue from section-sponsored events, dividends and interest on Section financial accounts, and other income. As such, NVSRM shall actively manage funds to promote growth and long-term well-being of investments and endowments.

3.7.1 **Actions**

Key actions for this goal are assuring a stable to growing balance on all accounts and coordinating with the Section Treasurer and Finance Committee to move funds as necessary to more secure and profitable investments with minimal loads, or fees. Success measures include maintenance of minimum account balances as established by NVSRM leadership, timely payment of accounts payable, and annual reporting to NVSRM membership.
